NOTIFICATION

No.154/LKD/2025-P.Admn. - In exercise of the powers conferred by sub-section (1) of section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Administration of Union Territory of Lakshadweep hereby designates Shri Gaurav Singh Rajawat, IAS (AGMUT:2011) as the Chief Electoral Officer for the Union Territory of Lakshadweep with effect from the date he takes over charge and until further orders.

2. Shri Gaurav Singh Rajawat shall cease to hold and hand over forthwith the charge of all or any charges of work under the Administration of Union Territory of Lakshadweep, which he may be holding before such assumption of office.

3. Shri Gaurav Singh Rajawat while functioning as the Chief Electoral Officer, Lakshadweep shall not hold any additional charge whatsoever under the Administration of the Union Territory of Lakshadweep except that he should be designated Secretary to the Administration of the Union Territory of Lakshadweep, in charge of Election Department in the Union Territory Secretariat.


